On the question:

Musewicz asked that it be sent to Mid Valley Athletic Director.

Lukasewicz asked that it be sent to Coaches & Directors/Appropriate Organization head.

Tomasovitch added to have it put on Borough letterhead.

Lukasewicz: and make sure it is brought back so we have it.

Mazak added that MV does their own field.

Discussion took place regarding Mid Valley fixing the field and their crew.

Tomasovitch feels should be consistent. If one team can fix the field the others should too.

Lukasewicz: Put in the rules once deemed unplayable can't use it. Won't let MV Do it then.

Musewicz: If you let one you have to let others.

Repchick: If they are willing to what needs to be done and you are satisfied with it

All talking at once.

Shevchick: Brought up O'Hara. Can't tell them no or charge them \$1000.00. Was going to put in

stipulation have to bring 10 bags of dry field and 10 bags of liner. That's what will cause to use the field.

Lukasewicz: They should do the same as Mid Valley.

Shevchick: If they don't have the capacity. Penn State wouldn't send anyone in. Would use 6 bags of our dry field and would replace it.

Lukasewicz: You coordinate everything.

Eddie Long: Typed it for Snooky and the first thing is that they cannot alter the field and by raking it they will alter the field.

Lukasewicz: When you have them sign it explain what you mean by alter. It will be at Mr. Shevchick's discretion how the field will be used.

Lukasewicz thanked Eddie for the field dedication.
