### **AUDIENCE COMMENTS:**

Dominick Rocco-About that four foot fence.

Barone-What about it?

Rocco-Is that for above ground pool, in ground pool?

Barnick-(unclear)... You know how you put a fence around your yard?

Rocco-I thought.....swimming pool.

Barnick-No.

Rocco-You don't need one above ground, right?

Morrell-That's why we did two separate motions, the first one was in reference to the swimming pools and the second motion was in reference to just fence, property fence.

Larry Hartshorn-I'm back on my road again. Rinaldi right, you should get him to get his stuff out to the road.....(unclear).....land, save you a lot of money. That's all his garbage down there, that's red ash and stuff, tell him to get it out of there. Give me permission to open the road, I'll load it myself. I'll get a loader from K.C. Jones, go down and open the road so I can get in my yard. Then I'll take all the responsibility of the insurance or whatever damages, I want a road to my yard so, I got my boat in somebody else's yard, I got a car in another yard, I can't get in my backyard, can't park out front, there's a fire hydrant.

(Someone spoke on the tape, unclear, and then a discussion took place.)

Bob Lokuta, 200 Phillips Street-First off I'd like to thank council for the acquisition of the machine to clean the floors over in the Civic Center. Feedback from the maintenance guys, fantastic. I think if you go over and you take a look at the floors you're going to see a dramatic difference. So I'd like to thank you for that, okay. This is the second month that I've tried to get some answers from this article that's in the paper and our controller seems to leave before audience comments. So I'm going to be forced to go through Freedom of Information Act and get this. If I can't get it here, peaceably, then we'll do it that way. I think it's horrible that we don't get a chance to address our questions to the elected officers. This is ridiculous. I'll do it through the courts and I'll get the information that I want and it'll be over with, but I think some kind of ground rules should be made that we are given the opportunity to address all elected officials and we're not. I mean, this is two months in a row.

Mraz-When we do roll call, does everybody, do you question everybody for roll call, Elaine? Morrell-At the beginning of the meeting?

Mraz-Correct.

Morrell-Yes.

Mraz-Well then how could somebody leave before a meeting is ended?

Barnick-(unclear)

Mraz-You know what I'm saying? The meeting isn't over....I mean, I mean, plain and simple, I don't know, you're addressed for attendance, then you have to......

Menichetti-Do you have a problem?

Mraz-No, I just have a question.

Menichetti-I can only sit here so long. I'm sitting here.....

Mraz-You're part of the meeting.

Barone-We're also sitting here too.

Menichetti-Why don't you adjourn already? It's time to go home.

Barone-Because we're not finished yet.

A discussion took place.

Mraz-Back to legalities, if you take roll call somebody leaves in between a meeting before the meeting's over.

Unknown-Unless they're excused.

Lukasewicz-I don't know, I guess you....excused.

Barone-I know every other council member or anybody that left before the end of the meeting, they excused themselves. Except this one. You want to ask her a question, Bob? Lokuta-I'll do it through the courts.

Barone-Okay.

Lokuta-I mean, if I can't get an answer like from everybody else, I'll do it through the courts and I'll get my answer that way in a reasonable amount of time.

Barone-Anybody else?

Lokuta-And it will be coming, the request through the courts will be coming, let me tell you. Barnick-Unbelievable.

Jack Dolan-I made a call to Rocco Valvano and a call to Dale Mecca and told them to stop working down there and explained the situation to them, they will be up to see you tomorrow with a check. He said he just go the letter day before yesterday.

Kalinoski-He still can't do anything until he has his.....(unclear).

Dolan-Well, (unclear)

Kalinoski-He won't have it tomorrow, I told him I won't even get to it till Tuesday.

Unknown-How about the change of the plans, too (unclear.)

Marushock-You did say he did submit the plans?

Mayor-How did he change the plans?

Kalinoski-Parking areas....(tape unclear).

Mayor-These are major things.

A discussion took place.

Mayor-(Tape unclear)..Rinaldi....remain in a state of limbo?

Barnick-He filed an appeal.

Mayor-He filed the appeal?

A discussion took place.

Cimini-I tried to explain to him, that the issue of whether or not the planning fees are paid versus developing that property are two separate issues so you can't mix them, I said you have to pay (unclear) fees and then you can go on with the development, he seems, he wants it combined both, he wants to go on with the development but not pay the planning fees. So I said you have, we have to reach some type of an agreement. He's using that as an argument that the borough doesn't want him to go through with the development because we're giving him a hard time with planning fees, I can't get it through his head that it's two separate issues.

Barnick-No, because prior to a couple a years ago when we took over it was a free ride.

Cimini-Yeah, he's using....

Barnick-....free ride.

Cimini-He said to me today, you know that they were kind enough to let the borough use their property for rent free for whatever, I don't know what you have on there, that's his argument, why can't you relinquish, why can't you take the whatever property you've been using in exchange for the planning fees and let them go on with their development.

Morrell-Why doesn't he give us that piece of property?

Marushock-....said a few years ago he was given a free ride, I was on the planning at that time and I know he resents......

Barnick-Did he give you a check?

(Everyone spoke at once.)

Cimini-He also made a comment today that the planning fees were waived, waive the planning fees.

(Everyone spoke at once.)

Cimini-Yes, he said someone waived the planning fees.

Barnick-Oh yeah, right.

Chrzan-He said that? He said that they waived the planning fees?

Barnick-.I hope we don't find a motion on that.

(Everyone spoke at once and a discussion took place.)

Dolan-One thing Rinaldi said at that hearing was he wants to divide that project into three phases. He only wants to pay a bond on the first phase.

Barnick-No, later on, Jack, he said he five phases.

Dolan-Well, whatever, he only wanted to put a bond on the first phase and I told him, I said, we just had Mr. Palumbo come up with one hundred twenty thousand dollars for his whole project, I said (unclear) pay a .....on the first phase now all of a sudden you quit. He said well, maybe, maybe something will happen tomorrow. I said yeah, maybe nothing will, I said you better be here to pay for the whole thing.....pay....nothing.

Jamie Shevchick-I'm over there in the Civic Center, could we look into something for maybe the bikes, park, some kind of bike rack?

Barnick-.....(unclear)....two years ago.

Lenore Dolan-Well, we did have one.

Morrell-We had one and it was......

(Everyone spoke at once.)

Barnick-It was sent back.

Chrzan-Jamie, you have permission from the.....get one tomorrow.
