

**ORDINANCE NUMBER # 2 OF 2014**

**AN ORDINANCE RESTRICTING PARKING FOR THE FULL LENGTH ALONG THE NORTHWESTERLY SIDE OF DEWEY STREET AND WITHIN FIFTY (50) FEET OF THE INTERSECTION ALONG THE SOUTHEASTERLY SIDE OF HAVERLY STREET AS WELL AS WITHIN FIFTY (50) FEET EACH SIDE OF THE INTERSECTION OF SANDERSON STREET**

*WHEREAS, pursuant to 67 Pa. Code Chapter 201 (Pa. Dot. Pub. 201) the Street Commissioner conducted a review/study of a portion of the 300 and 400 block of Haverly Street on or about June 5, 2013; and,*

*WHEREAS, pursuant to said reviews/study of said intersection, a recommendation was made by the Street Commissioner; and,*

*WHEREAS, Dewey Street has two intersection approaches made up of Sanderson Street at its southwesterly terminus and Haverly Street which intersects at its northeast terminus; and,*

*WHEREAS, a study was instituted by motion of Throop Borough Council dated May 28, 2013 as a result of complaints from residents on April 27, 2013;*

*WHEREAS, pursuant to said review/study a recommendation was made and it was recommended that Dewey Street can be restricted for the full length along the northwesterly side of Dewey Street and within fifty (50) feet of the intersection along the southeasterly side of Haverly Street as well as within fifty (50) feet of each side of the intersection of Sanderson Street; and,*

*WHEREAS, it is the desire of Throop Borough Council to accept and adopt said recommendation.*

*NOW THEREFORE be it ordained and enacted by the Council of the Borough of Throop as follows:*

- 1. Throop Borough Council hereby adopts the recommendation of the Street Commissioner as it appears in an engineering and traffic study dated June 5, 2013.*
- 2. In conjunction with said recommendation, parking will be prohibited for the full length along the northwesterly side of Dewey Street and within fifty (50) feet of the intersections along the southeasterly side of Haverly Street as well as within fifty (50) feet each side of the intersection of Sanderson Street.*

**SECTION 1.**

*If any section, clause, provision or portion of this ordinance shall be held invalid or unconstitutional by any Court of competent jurisdiction, such decision shall not affect any other section, clause, provision or portion of this Ordinance so long as it remains legally enforceable minus the invalid portion. The Borough of Throop reserves the right to amend this Ordinance or any portion thereof from time to time as it shall deem advisable in the best interests of the promotion of the purposes and intent of this Ordinance and the effective administration thereof.*

**SECTION 2.**

*This ordinance shall become effective thirty days after its enactment.*

**SECTION 3.**

*This Ordinance is enacted by the Council of the Borough of Throop under the authority of the Act of the Legislative, as amended, December 12, 1990, P.L. 1994, No. 220, and any other applicable law arising under the laws of the Commonwealth of Pennsylvania.*
