1 ATTY. CIMINI: This is the time and
2 date scheduled for a public hearing
3 regarding Throop Borough Council's ordinance
4 to amend the subdivision and land
5 development ordinance. There were two
6 public hearing notices in the Scranton Times
7 published March 29, 2018 and April 5, 2018.

8 We also received, and will be
9 attached as an exhibit, a letter from the
10 chairman of the planning commission, Anthony
11 Amico. He sent a letter dated April 5,
12 2018. I will read it into the record.

13 "Dear Council, the purpose of this
14 correspondence is to inform you that the
15 Throop Borough Planning Commission, at our
16 April 4, 2018 meeting, passed a motion that
17 it concurs with and has no objection to
18 proposed amendments to the Throop Borough
19 subdivision and land development ordinance
20 whereby the Throop Borough Planning
21 Commission will now act as an advisory
22 commission to Throop Borough Council with
23 duties and responsibilities as set forth in
24 ordinance No. 8 of 2018."

25 For the public's information, the

1 requested ordinance by Throop Borough
2 Council was -- the current subdivision and
3 land development ordinance is administered
4 by the Throop Borough Planning Commission.
5 The amendment will now make the Throop
6 Borough Planning Commission advisory in its
7 role to the Throop Borough Council.

8 Throop Borough Council will have
9 final decision and authority on any
10 decisions required under the subdivision and
11 land development ordinance. The code
12 enforcement officer, Bob Lokuta, will be
13 enforcing the ordinance, and the Throop
14 Borough Planning Commission will have job
15 duties and responsibilities as set forth in
16 the most recent ordinance which was passed
17 by borough council. That is ordinance No. 8
18 of 2018. That's it.

19 Anybody on council have any
20 questions? Anybody in the audience have any
21 questions?

22 So there are no objections to the
23 ordinance being amended, so that Throop
24 Borough Council will have final decision and
25 authority on all subdivision and land

development issues.

The meeting is concluded.
