

ORDINANCE #4 of 2019

AN ORDINANCE OF THE BOROUGH COUNCIL OF THE BOROUGH OF THROOP, LACKAWANNA COUNTY, PENNSYLVANIA, RESTRICTING PARKING ON PORTIONS OF DUNMORE STREET FROM THE INTERSECTION OF LINE STREET TO THE INTERSECTION OF MURRAY STREET, IN ORDER TO IMPROVE PUBLIC SAFETY AND SIGHT DISTANCE ALONG THE SUBJECT STREET AND INTERSECTIONS.

BE IT ORDAINED AND ENACTED, BY THE BOROUGH COUNCIL OF THE BOROUGH OF THROOP AND IS HEREBY ORDAINED AND ENACTED BY THE AUTHORITY OF THE SAME AS FOLLOWS:

WHEREAS, The Borough of Throop, (hereinafter "Borough") is responsible for enacting Ordinances and enforcing matters associated with the health, safety and welfare of the Borough's residents; and

WHEREAS, The Borough of Throop, finds that it is in the best interest of its residents to restrict parking along Dunmore Street (SR 0347).

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Borough Council of the Borough of Throop as follows:

ARTICLE I:

Parking along the East side of Dunmore Street (SR 0347) from the intersection of Line Street to the intersection of Murray Street shall be restricted and/or prohibited entirely.

ARTICLE II:

Parking along the West side of Dunmore Street (SR 0347) from the intersection of Line Street to the intersection of Simpson Street shall be restricted and/or prohibited as follows: Starting at the corner of Line Street to a point 114 feet to the north, then from a point 178 feet north of Line Street a distance of 268 feet north, and then from a point 519 feet north of Line Street to the corner of the intersection with Simpson Street.

ARTICLE III:

Parking along the West side of Dunmore Street (SR 0347) from the intersection of Simpson Street to the intersection of Clearfield Court shall be restricted and/or prohibited entirely.

ARTICLE IV:

Parking along the West side of Dunmore Street (SR 0347) from the intersection of Clearfield Court to the intersection of Sanderson Street (SR 2008) shall be restricted and/or prohibited entirely.

ARTICLE V:

Parking along the West side of Dunmore Street (SR 0347) from the intersection of Sanderson Street (SR 2008) to a point 245 feet north shall be restricted and/or prohibited.

ARTICLE VI:

Parking along the West side of Dunmore Street (SR 0347) from the intersection of Meade Street to the intersection of Center Street shall be restricted and/or prohibited entirely.

ARTICLE VII:

Parking along the West side of Dunmore Street (SR 0347) from the intersection of Center Street to the intersection of Clark Street shall be restricted and/or prohibited entirely.

ARTICLE VIII:

Parking along the West side of Dunmore Street (SR 0347) from the intersection of Clark Street to a point 136 feet north of the corner of Clark Street shall be restricted and/or prohibited.

ARTICLE IX:

Parking along the West side of Dunmore Street (SR 0347) from the intersection of Adams Court to a point 150 feet north of the intersection of Murray Street shall be restricted and/or prohibited entirely.

ARTICLE X:

Repealer: All ordinances or parts of Ordinances which are inconsistent herewith are hereby repealed.

ARTICLE XI:

Severability: If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality, or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of the Ordinance. It is hereby declared as the intent of the Borough that this Ordinance would have been adopted as if such unconstitutional, illegal or invalid provision, sentence, clause, section, or part thereof had not been included therein.

ARTICLE XII:

Any person who violates any provision of the Ordinance shall, upon conviction, be sentenced to pay a fine of Twenty-five Dollars (\$25.00) plus costs.

ARTICLE XIII:

This Ordinance shall take effect immediately upon adoption.
